- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Generic

ELIGIBILITY CRITERIA

A proof in support of the following criterion by the Bidder shall be sub mitted through GeM Portal.

- The firm should have registered with GST, PAN and MSME authorities and the firm should upload the scanned copies.
- EPF and ESI registration copies must be uploaded along with the bid
- Scanned copies of Income Tax Returns/Turnover of the company/fir m for the past three financial years (2021-22, 2022-23 and 2023-24) shall be uploaded as given in the technical bid.
- Scanned copies of Service Tax / GST Returns of the Company/firm for the past three financial years (2021-22, 2022-23 and 2023-24) shall be uploaded as given in the technical bid.
- The selected agency has to execute an agreement with the Central Council for Research in Siddha, Chennai initially for a period of Two ye ars, which can be extended further for a period of 06 months based the on satisfactory performance of the Bidder. The cancellation of agreement can be done by either side with a notice period of one month.
- The bidder should upload the details of vehicle registration and renewal, if any.
 - The bidder should upload the copies of Purchase order / Work order/ Work completion Certificate pertaining to hiring of Vehicle by other Go vernment Offices/Autonomous bodies/PSUs in the **recent past 3 years**, in support of the bidders past experience.

- Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits within the Districts of Chennai, Chengalpattu, Kancheepuram and Tiruvallur, where the services need to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents within these geographical locations as a proof of having the office establishment.

 - ii. Electricity bill for last one year in the name of the Firm or
 - iii. GSTIN registration or

PAYMENT TERMS

- 1. Invoice/Bills should be submitted on monthly basis with all supporting records and payment will be made within 7 days from the date of submission of bills **after deducting TDS as applicable**.
- 2. The log book will be maintained and verified before making the pay ments.
- 3. The log book be maintained perfectly and should be endors ed by the office using the vehicle for each and every entry with out fail.
- 4. **EXTRA HOUR CHARGES (REIMBURSABLE COST):** If the vehicle is deploy ed beyond 10 hours on any particular day, the extra hour charges admissible sh all be paid by the Council @ Rs.150/- per hour excluding GST on reimbursement basis.
 - 5. If any discrepancy and / or indifference in rendering the service i s found, CCRS will cancel the tender at any time.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
